

TERMS AND CONDITIONS

Nick Wood Professional Golf Ltd is a privately owned company based in England. We organise golf tuition tours in Italy. Please note: We are not a tour operator in the sense of package holiday law.

This document contains the binding conditions of participation. By booking and participating in the programme, customers expressly accept these conditions.

1. RESERVATION

- Bookings are generally made from Saturday to Saturday. Late arrival or early departure does not entitle the customer to a price reduction.
- Places are allocated on a 'first come, first served' basis and only become valid upon receipt of a deposit.
- If the number of participants is insufficient, the provider reserves the right to cancel the week.

2. TERMS OF PAYMENT

- Total price: The full price of the golf holiday must be paid in advance.
- Deposit: A non-refundable deposit of 20% of the total amount is required to confirm the booking. Only after payment is the reservation binding.
- Final payment: The remaining 80% must be paid no later than 30 days before the start of the programme. In the event of late payment, the booking may be cancelled and the deposit retained.
- Method of payment: Only payment by bank transfer is accepted. All prices are in Euro (EUR) unless otherwise stated. Any bank charges shall be borne by the customer.

3. CANCELLATION CONDITIONS

Cancellation by the customer:

- Up to 35 days before the start of the course: full refund of the remaining payment (deposit non-refundable)
- 34 to 15 days before the start: refund of 50% of the remaining payment
- Less than 15 days: No refund of the remaining amount

Cancellation by the provider:

In the event of cancellation by us, you will either receive a full refund or a credit note for use on a later course.

4. TAXES AND DUTIES

Local taxes such as the city tax - unless expressly included in the price - are to be paid directly at the hotel.

5. PROGRAMME & SAFETY

The course includes structured golf lessons, tailored to different levels of play.

- Participants must communicate any physical limitations or medical conditions in advance.
- All safety instructions given by the instructors must be strictly followed. The provider accepts no liability for injuries caused by disregard.

6. ACCOMMODATION & FACILITIES

- Accommodation is provided as part of the package. Room types range from shared rooms to private rooms, subject to availability.

- Use of the golf facilities (incl. practice area and course) is included in the package.
- Additional amenities (e.g. restaurant visits, excursions) may be subject to a charge.
- The provider is not liable for course conditions that may be affected by weather or maintenance work

7. LIABILITY & INSURANCE

- The provider accepts no responsibility for the loss of or damage to personal belongings.
- Comprehensive travel insurance is strongly recommended - especially with cover for sports activities, cancellations and emergencies.

8. RULES OF BEHAVIOUR

- All participants are expected to treat staff, teachers and other guests with respect.
- Disruptive or inappropriate behaviour may result in immediate exclusion from the programme - without refund.

9. FORCE MAJEURE

The provider is not liable for disruptions to services due to unforeseeable circumstances beyond its control (e.g. natural events, official measures).

10. DATA PROTECTION

We only collect the necessary personal data (name, telephone number, e-mail address) and only pass on the name to the booked hotel. Your data is protected in accordance with the applicable data protection regulations.

11. ACCEPTANCE OF THE TERMS AND CONDITIONS

Upon receipt of the deposit, you confirm that you have read, understood and accepted these terms and conditions in full.
